* Neither Party shall be liable for any failure or delay in performing an obligation under this Agreement that is due to any of the following causes, to the extent beyond its reasonable control: acts of God, accident, riots, war, terrorist act, epidemic, pandemic, quarantine, civil commotion, breakdown of communication facilities, breakdown of web host, breakdown of internet service provider, natural catastrophes, governmental acts or omissions, changes in laws or regulations, national strikes, fire, or explosion.

For the avoidance of doubt, this provision shall not include (a) financial distress nor the inability of either party to make a profit or avoid a financial loss, (b) changes in market prices or conditions, or (c) a party's financial inability to perform its obligations hereunder.

* At staff's discretion, a deposit may be required for any rental. Any or all of this deposit may be used by the City to cover any damages caused by the rental.

* The RRPDCAD reserves the right to cancel, postpone or reschedule any rental. The renter will be given a choice of a refund or to have another date scheduled.

* Please call **678-582-1424** for rain out info. For police assistance please call the non-emergency police number. If the RRPDCAD cancels a field due to rain, a refund will be issued. If the renter cancels due to weather conditions but the RRPDCAD has not cancelled the field, fees will still apply.

Cancellation: Should the LESSEE desire to cancel the use of the Building as outlined in this agreement, the following penalties shall be assessed: More than 30 day notice - full refund minus \$15 processing fee; 14-30 days notice - 25% cancellation fee; 7-13 days notice - 50% cancellation fee; less than 7 days notice - only the damage deposit will be refunded, all rental and staffing fees will be retained
